Water Quality Protection Insteam Target Values:									
	Dissolved Oxygen (DO)								
	Water Quality Target Value for Dissolved Oxygen (DO) is greater than 5.0 mg/l to meet the Massachusetts Class B								
	Water Quality Standards for warm water freshwater fisheries and the SB DO criterion for marine waters.								
	Total Suspended Solids (TSS)								
	Total Suspended Solids (TSS) is a measure of particulates in the water. There is no Water Quality Standard for TSS.								
	We are looking for unusually high values that may indicate an erosion or poor stormwater management								
	problem upstream. High levels of TSS can smother aquatic life and destroy benthic habitat.								
	Only very turbid samples are analyzed and reported. <b>Analyzing turbid samples only.</b>								
	pH								
	The Water Quality Standard for pH in class B waters is 6.5 through 8.3 and not more than 0.5 units outside the natural range.								
	Wetlands, swamps, bogs, pine forest tend to have natural low pH. Field pH strips are sometimes used to identify								
	extremes of pH such as that caused by a spill of industrial waste. Reported results are from samples analyzed								
	by Veolia Taunton WWTP lab using a calibrated pH meter.								
	Temperature (Degrees C)								
	The Water Quality Standard for Temperature in class B waters is that it shall not exceed 83°F (28.3°C) in warm water fisheries.								
	The Temperature in class SB waters shall not exceed 85°F (29°C) nor a maximum daily mean of 80°F (26.7°C).								
	Natural seasonal and daily variations that are necessary to protect existing and designated uses shall be maintained.								
	There shall be no changes from natural background conditions that would impair any use assigned to this Class,								
	including those conditions necessary to protect normal species diversity, successful migration, reproductive								
	functions or growth of aquatic organisms.								
	TRWA sampling locations TNT-01 and TNT-02 are in class SB waters all others are in class B waters.
